THE BARKING LOT, INC. AGREEMENT

In consideration for services rendered to the Client by The Barking Lot, Inc. the Client waives any claims, actions or demands of any nature foreseen or unforeseen, that he/she may have now or in the future, against The Barking Lot, Inc. relating to care, control, health and/or safety of the Client's dog arising during pick up, transport, drop off and stay at the facilities which the Client's dog is being cared for.

Due to many outstanding benefits of dog socialization and The Barking Lot's commitment to the safety and well-being of the Client's dog, the Client agrees that the benefits of socialization outweigh the risk. Furthermore, the Client requests a socialized environment for their dog while under the care of The Barking Lot, Inc.

The Client agrees to assume all liabilities & responsibilities, financial or otherwise, for the behavior and health of the Client's dog. The Client agrees to hold The Barking Lot, Inc. harmless from any claims and actions, or demands against The Barking Lot, Inc. arising during the transport or stay at The Barking Lot, Inc. facilities.

The Client authorizes The Barking Lot Inc. to do whatever they deem necessary for the safety, health and well-being of the Client's dog while under the care of The Barking Lot, Inc.

If, at the completion of the agreed upon boarding, daycare, grooming or training time the Client's dog is not picked up by the owner, and the payment of all charges made in full, including medical, veterinarian, or boarding charges as provided herein, The Barking Lot, Inc. shall notify the owner by certified mail at the address provided by owner on file, that the dog will be held for an additional (10) ten days following the date of the mailing notice. At the end of the (10) ten day period, if there is no response from the owner, the dog may be sold at public or private sale or adopted out at public or private adoption. The proceeds of such sale shall first be applied to the outstanding charges of The Barking Lot, Inc., and the balance, if any, shall be returned to the owner at the address on record. Owner shall be charged for any such additional days following the notice at The Barking Lot's then existing daily boarding rate.

Owner represents that the owner is a legal owner of the dog, that the dog is free and clear of any mortgage or other encumbrance; that the dog has not been exposed to distemper, parvo, rabies or bordatella (kennel cough) within the last (30) thirty days; that the dog has been inoculated as indicated by the records presented; that the dog is currently properly licensed; and that the owner has read this agreement in its entirety.
